RE: Natural Gas Supplier License Application

Dear Mr. Ellis:

On December 20, 2024, the Pennsylvania Public Utility Commission (Commission) received ACCENTURE LLP's Application for a Natural Gas Supplier (NGS) license.

The applicant stated throughout its NGS Application Package that the name of the applicant is "Accenture LLP". According to the applicant's PA Department of State registered name, the name must be written as "ACCENTURE LLP" (notice the capitalization differences). All instances of this error must be corrected throughout the NGS Application Package.

Sections 2.b, 5.b, 5.c, 7.a, 11.a, and 11.b of the Application were incomplete or not properly completed (ex. #2.b has an incorrect box checked and #11.a has an incorrect applicant name and county). In order for the Commission to accept the Application for review, these deficiencies must be corrected. Failure to respond timely will result in the Application being deemed rejected<sup>1</sup> and the docket will be closed.

Please use the Commission's e filing system or an overnight delivery service to submit the requested information to the Secretary of the Commission **within 20 days** from the date of this letter. Please submit revised Application pages for each section. The Commission accepts all public documents through our e filing system and strongly recommends companies open an e filing account through the Commission's website at <https://efiling.puc.pa.gov>. Use of the e filing system will ensure that submissions by the company are received timely and receipt can be verified.

If your filing contains confidential material, you are required to either file by overnight delivery or submit to the Secretary's Share Point File system to ensure the timely filing of your

submission. Filers should contact the Secretary's Bureau in advance to gain access to the Share Point File system. Make sure to reference the Docket Number listed above and mark the materials "CONFIDENTIAL" in bold or highlighted manner if any of the requested information is deemed to be of a confidential nature.
