On February 21, 2025, Buck Hill Water Company ("Buck Hill") received a Secretarial Letter dated January 23, 2025 in Docket No. L-2020-3019521 regarding noncompliance with the requirement to file a Lead Service Line Replacement ("LSLR") program petition. The letter advised that, if an LSLR program petition is not filed by February 21, 2025, this matter could be referred to the Commission's Bureau of Investigation and Enforcement for review and such further action as may be deemed necessary.
