The Pennsylvania Public Utility Commission (PUC) will conduct four Public Input Hearings concerning Pike County Light & Power Company's general rate increase requests to produce additional operating revenues of \$2,143,900 per year above existing rates for electricity. The Company also proposes increasing its rates to produce additional annual operating revenues of \$905,900 per year in total gas distribution revenues. - (4) your email address, if you have one.

Failure to pre-register could result in you not being called to testify by the PUC judge.

Additionally, if more than one person in your household would like to testify, one person may pre-register for other individuals in the same household by providing the PUC Judges' Legal Assistant with the above-listed information for each individual.
