Re: Natural Gas Supplier License of Interstate Gas Supply, LLC d/b/a IGS Energy

Dear Mr. Stewart:

On September 5, 2024, Interstate Gas Supply, Inc. d/b/a IGS Energy (Interstate Gas Supply) filed a request with the Pennsylvania Public Utility Commission (Commission) to change the name on its license to provide natural gas services, as a supplier, to Interstate Gas Supply, LLC d/b/a IGS Energy.

By Secretarial Letter dated January 23, 2018, at Docket No. A-2018-2640777, Interstate Gas Supply was licensed to provide natural gas services as a supplier to residential, small commercial (less than 6,000 MCF annually), large commercial (6,000 MCF or more annually), industrial, and governmental customers in the natural gas distribution company (NGDC) service territories of Columbia Gas of Pennsylvania, Inc., National Fuel Gas Distribution Corporation, PECO Energy Company, Peoples Natural Gas Company, LLC, Peoples Natural Gas Company, LLC – Equitable Division, Philadelphia Gas Works, and UGI Utilities Inc. within the Commonwealth of Pennsylvania.

With this Secretarial Letter, the Commission approves the change of Interstate Gas Supply, Inc. d/b/a IGS Energy's name on its license for the provision of natural gas services as a supplier. Additionally, the Commission updates Interstate Gas Supply's license to correctly list its NGDC service territories, including the full Peoples Natural Gas Company, LLC service territories.

**The Secretary's Bureau will issue a new license to Interstate Gas Supply, LLC d/b/a IGS Energy the right to begin to offer, render, furnish, or supply natural gas services as a supplier to residential, small commercial (under 6,000 MCF annually), large commercial (6,000 MCF or more annually), industrial, and governmental customers in the natural gas distribution company service territories of Columbia Gas of Pennsylvania, Inc., National Fuel Gas Distribution Corporation, PECO Energy Company, Peoples Natural Gas Company, LLC – Peoples Natural Gas Division, Peoples Natural Gas Company, LLC – Peoples Gas Division, Philadelphia Gas Works, and UGI Utilities, Inc., within the Commonwealth of Pennsylvania.**

**The Secretary's Bureau and the Bureau of Administration, Financial and Assessments will update the company's name in their computer systems and lists, as appropriate, to be Interstate Gas Supply, LLC d/b/a IGS Energy.**
