History of proceeding:

On January 27, 2025, UGI Utilities, Inc. - Gas Division ("UGI Gas" or the "Company") filed Supplement No. 55 to UGI Gas Tariff - PA P.U.C. Nos. 7 and 7S, seeking a general rate increase pursuant to 66 Pa.C.S. § 1308 of the Public Utility Code.

In this filing, UGI Gas proposed to increase its annual jurisdictional revenues by approximately \$110.395 million, or by 9.7% on a total revenue basis. Average customer bill impacts are detailed in the enclosed Statement of Reasons. UGI Gas is proposing that the new distribution rates become effective for service rendered on or after March 28, 2025.
