MOTION FOR ADMISSION *PRO HAC VICE*

Pursuant to 52 Pa. Code § 1.22(b), Pa.B.A.R. 301(b), and Pa. R.C.P. No. 1012.1, Mark E. Belland, Esq. (“Sponsor”) moves for the admission *pro hac vice* of Morgan L. Bigelow, Esq. (the “Candidate”) to appear on behalf of Local 777 of the International Brotherhood of Electrical Workers, AFL-CIO (“IBEW Local 777”) in the above-captioned proceeding of the Pennsylvania Public Utility Commission (the “Commission”).
