**PHILADELPHIA GAS WORKS' MOTION TO CONTINUE**

Pursuant to 52 Pa. Code §1.15, Philadelphia Gas Works (“PGW”) hereby files this Motion to Continue the evidentiary hearing in this matter, which is scheduled for Thursday, March 13, 2025. In support of this Motion, PGW states as follows:

1. By notice dated January 22, 2025, the Commission scheduled a hearing in this matter for Thursday, March 13, 2025 at 10:00 a.m., before Administrative Law Judge Eranda Vero.
2. Pursuant to 52 Pa. Code §5.231(a) and the Prehearing Order issued in this matter, PGW is working with the Complainant to reach a resolution in this matter.
3. The parties have communicated regarding working to resolve the matter; however, the parties have not yet reached an agreement.
4. PGW and the Complainant need additional time to attempt to resolve this matter.
5. PGW has spoken with Mr. Kalfus via email to discuss this request to continue the hearing.
6. Mr. Kalfus has stated that he has no objection to PGW’s Motion and that he agrees that additional time to discuss proposed designs would be beneficial.
