On February 28, 2025, the Pennsylvania Public Utility Commission (Commission) received GRUPP HOLDINGS, LLC dba Green Climate Energy Consulting's Application for a Natural Gas Supplier (NGS) license.

Sections 1.b and 2.b of the Application were incomplete or not properly completed. In order for the Commission to accept the Application for review, these deficiencies must be corrected. Failure to respond timely will result in the Application being deemed rejected<sup>1</sup> and the docket will be closed.

Please submit revised Application pages for each section. The Commission accepts all public documents through our efilings system and **strongly** recommends companies open an efilings account through the Commission's website at <https://efiling.puc.pa.gov>. Use of the efilings system will ensure that submissions by the company are received timely and receipt can be verified.

If your filing contains confidential material, you are required to either file by overnight delivery or submit to the Secretary's Share Point File system to ensure the timely filing of your submission. Filers should contact the Secretary's Bureau in advance to gain access to the Share Point File system. Make sure to reference the Docket Number listed above and mark the materials "CONFIDENTIAL" in bold or highlighted manner if any of the requested information is deemed to be of a confidential nature.


