**PHILADELPHIA GAS WORKS' MOTION TO CONTINUE**

Pursuant to 52 Pa. Code §1.15, Philadelphia Gas Works (“PGW”) hereby files this Motion to Continue the evidentiary hearing in this matter, which is scheduled for Friday, March 21, 2025. In support of this Motion, PGW states as follows:

1. By notice dated January 29, 2025, the Commission scheduled a hearing in this matter for Friday, March 21, 2025 at 10:00 a.m., before Administrative Law Judge Eranda Vero.
2. Counsel for PGW, Graciela Christlieb, Esq., is unavailable to appear at the scheduled time of the hearing due to a scheduling conflict involving another legal matter.
3. Additionally, PGW is still in the process of investigating the issues raised in the Complaint and requires more time to complete its investigation.
4. PGW has spoken with Ms. Tesfaye to discuss this request to continue the hearing.
5. Ms. Tesfaye has stated that she does not object to PGW’s Motion and has provided PGW with her availability for purposes of rescheduling the hearing in this matter. Ms. Tesfaye has indicated that Fridays are better for her, but has asked that the Commission avoid April 11, 2025, May 23, 2025, June 20, 2025, and June 27, 2025.
6. Counsel for PGW is also unavailable on May 9, 2025.

WHEREFORE, PGW requests that the hearing scheduled for Friday, March 21, 2025, in the above captioned matter be continued.
