To Whom It May Concern:

In the Order entered February 3, 2025, the Motion for Default Judgment filed by the Commission's Bureau of Investigation and Enforcement on June 10, 2024, was granted. The original Order stated that if the outstanding assessments of \$94 and a civil penalty of \$1,200 were not paid within thirty (30) days of the entry date of the Order, the Certificate of Public Convenience held by ON TIME TRANSIT, INC., at Application Docket No. A-2016-2549947 would be cancelled without further action by this Commission.

To date, more than thirty days later, the respondent has not paid their civil penalty in full; therefore, the Certificate of Public Convenience held by ON TIME TRANSIT, INC., at Application Docket No. A-2016-2549947 has been cancelled.

Furthermore, this Commission will request the Pennsylvania Department of Transportation to put an administrative hold on the Respondent's vehicle registrations. Respondent will **NOT** be able to register any new vehicles or renew any existing vehicle registrations until all past due assessments are paid, all past due fines are paid, all insurance filings are up to date, and it holds an active Certificate of Public Convenience issued by this Commission.

Respondent is hereby notified to cease and desist from further violations of the Public Utility Code, 66 Pa. C.S. §§1.1 et seq., and the regulations of the Commission, 52 Pa. Code §§1.1 et seq. In view of the **cancellation of respondent's Certificate of Public Convenience**, it is specifically prohibited from rendering service as a common carrier by motor vehicle in intrastate commerce in the Commonwealth of Pennsylvania.
