- 1.) Is 238 Avon Road, Upper Darby, PA 19082 a business address or a private residence? If it's a business office, the property should be listed on your balance sheet.

- 2.) Please know that you will be asked to provide a vehicle list upon approval of your application. All three cars must be registered to and insured by Grand Crown Limo LLC at that point.

- 3.) The Balance Sheet you submitted should consist of accurate information and not be rounded. The information provided is also to be strictly limited to assets and debts HELD BY THE APPLICANT (GRAND CROWN LIMO LLC) and not the individual members. Any property listed must be registered or titled to the Corporation – personal property should not be included. If assets need transferred to the applicant from the individual member(s) then this should be done prior to submitting this response so that the balance sheet is an accurate reflection of the applicant's financial position. If you are unsure of how to properly prepare the balance sheet, then you should consult with an accounting professional PRIOR to resubmitting a balance sheet.
