PPL Electric Utilities Corporation (“PPL Electric” or the “Company”) respectfully submits this status report in compliance with. Ordering Paragraph 3 of the Interim Order Holding Respondent’s Preliminary Objection in Abeyance and Granting Motion to Stay that was issued on October 21, 2024, in the above-captioned Second Formal Complaint proceeding. Per Ordering Paragraph 3 of that Order, the parties were directed to “file a status report, and any appropriate motion, within 20 days of the entry of the Commission’s Final Order in Docket Number C-2019-3008272.”

On February 28, 2025, the Pennsylvania Public Utility Commission (“Commission”) entered its Opinion and Order in the First Formal Complaint proceeding at Docket No. C-2019-3008272 granting in part and denying in part the Exceptions of Michael and Sharon Hartman (“Complainants”), denying the Exceptions of PPL Electric, and adopting the Initial Decision of Administrative Law Judge Steven K. Haas as modified. On March 17, 2025, PPL Electric filed a Petition for Stay or Supersedeas Pending Judicial Review of the Commission’s February 28, 2025 Order, which remains pending before the Commission.

The parties have conferred about the status of the Second Formal Complaint proceeding and are engaging in settlement discussions to see whether they can resolve the Second Formal Complaint.

As such, PPL Electric respectfully requests that the parties provide Your Honor with a further status report within 30 days, i.e., by April 21, 2025. The Company has consulted with the Complainants about this proposal and is authorized to represent that they support this request.
