My name is Elijah Mims, and I am the owner of Community Connection Transportation L.L.C., a Non-Emergency Medical Transportation (NEMT) company based in Doylestown, Pennsylvania. I am submitting this petition to request reconsideration due to circumstances beyond my control that have delayed my ability to obtain commercial insurance coverage. I have made every effort to comply with the necessary requirements in a timely manner, but the unexpected difficulties in securing an insurance policy have prevented me from proceeding as planned. The reasons below are why this matter should be reconsidered.

1. I have worked diligently with an insurance broker to obtain a commercial insurance policy, but the process has taken an uncommonly long time. My broker has informed me that insurance companies have become increasingly hesitant to issue policies to NEMT businesses, which has significantly delayed my ability to obtain coverage. I have a spotless driving record, no criminal history, and four years of experience in the NEMT industry, making me a strong candidate for commercial insurance. Despite my qualifications, insurance companies have

provided arbitrary reasons for denying coverage, such as my residency in New Jersey while operating a business in Pennsylvania.

2. I currently have a contract pending with a large hospital chain and a major nursing home chain, both of which are prepared to work with my company as soon as I secure an insurance policy. My business will address a critical need for transportation services among seniors and individuals with disabilities in Pennsylvania. Additionally, the approval of my business will contribute to job creation within the state, further benefiting the community. Given the circumstances beyond my control and the significant impact this delay has had on my ability to operate, I respectfully request that this matter be reconsidered. I have acted in good faith throughout this process and remain committed to meeting all necessary requirements as soon as I am able to obtain the required insurance coverage.


