**Request for Second Extension to File Petition**

Dear Secretary Chiavetta:

By Secretarial Letter dated February 28, 2025, the Pennsylvania Public Utility Commission (“Commission”) granted the request of Buck Hill Water Company (“BHWC”) for a 30-day extension to file its Lead Service Line Replacement Program (“LSLRP”). BHWC respectfully requests another 30-day extension to prepare its LSLRP.

An LSLRP is a complex document requiring the attention of many members of BHWC’s administrative and operational staff. BHWC is making every effort to prepare the document for filing as quickly as possible. Unfortunately, BHWC’s fiscal year-end has required that staff devote considerable time and attention to other matters, preventing the completion of the LSLRP in the time frame that BHWC originally anticipated. Another extension of thirty days will allow BHWC to prepare a much better document for filing with the Commission, which is in the interest of all parties.
