Detailed below are the answers to the data request dated March 17, 2025, pertaining to the application of the above carrier:

1. The address listed on the Application at 238 Avon Road, Upper Darby, Pennsylvania is a home address which will be the base of operation for the business and where all records will be kept. It is not owned by the business.
2. The Applicant is aware that they will need to transfer their existing vehicles and have them registered in the name of the company upon grant of authority. Unfortunately they cannot make that transfer now because they cannot be granted limousine plates until authority is granted.
3. The Applicant, like many limousine applicants, is a new entity. They have personal assets that they are willing to contribute to the business as needed but they are not presently assets of the company. The cash they have initially infused is contained within their balance sheet. I have provided a copy of their bank statement hereto as requested. The three vehicles shall be added to the company's assets upon grant of authority and shall immediately therein become balance sheet assets of the business.


