Dear Attorney Nase:

On January 23, 2025, the Pennsylvania Public Utility Commission (Commission) served notice to Buck Hill Water Company (Buck Hill) that the Commission did not receive a lead service line replacement (LSLR) program petition from your client by the required deadline. Pursuant to 52 Pa. Code § 65.55(a), a Class B public utility, Class C public utility or municipal corporation was required to file an LSLR program petition by July 22, 2024.

On February 24, 2025, Buck Hill filed the above-captioned document (Extension Petition) with the Commission requesting a 30-day extension to file its LSLR program. The Commission granted Buck Hill's Extension Petition by Secretarial Letter dated February 28, 2025, that indicated the LSLR program petition was due by March 26, 2025. Subsequently, Buck Hill filed a second petition (Second Extension Petition) dated March 25, 2025, that requested an additional 30-day extension for Buck Hill to file its LSLR program. Please be advised your request is hereby granted, and Buck Hill's LSLR program petition is now due by April 25, 2025.

If you are dissatisfied with the resolution of this matter, you may, as set forth in 52 Pa. Code § 5.44, file a petition for reconsideration of the actions of staff with the Commission within 20 days of the date this letter is served. Should you have any questions, please contact Matthew T.
