Dear Secretary Chiavetta:

Pennsylvania-American Water Company (“PAWC”) was appointed as receiver of Rock Spring Water Company (“Rock Spring”) by the Opinion and Order entered March 21, 2025 of the Pennsylvania Public Utility Commission (“Commission”) at the above-referenced docket. On March 31, 2025, Rock Spring is required to file a statement under oath showing its gross intrastate operating revenues for the preceding calendar year in order for the Commission to calculate Rock Spring’s assessment. Because PAWC was only recently appointed as receiver, it does not yet have sufficient access to Rock Spring’s historic financial information to file this statement under oath by the March 31 deadline. Accordingly, PAWC respectfully requests that the Commission estimate Rock Spring’s assessment as permitted under 66 Pa. C.S. § 510(b). If the Commission needs more information from PAWC to assist in calculating this estimate moving forward, please do not hesitate to contact me. PAWC expects to gain a better understanding of Rock Spring’s financial records over the coming weeks.

In addition, pursuant to 52 Pa. Code § 65.19, Rock Spring’s annual financial report will be due on April 30, 2025. PAWC currently does not have sufficient information to complete this report accurately. Accordingly, PAWC intends to begin preparing this report and file it at the Commission as soon as possible. To the extent PAWC is unable to file by the April 30, 2025 deadline, PAWC will file the report on a *nunc pro tunc* basis.
