**BUREAU OF INVESTIGATION AND ENFORCEMENT
MOTION FOR CONTINUANCE OF HEARING**

TO ADMINISTRATIVE LAW JUDGE ERIN GANNON:

The Bureau of Investigation and Enforcement (“I&E”) of the Pennsylvania Public Utility Commission (“Commission”), pursuant to 52 Pa. Code § 1.15(b), hereby submits this Motion for Continuance of Hearing to continue the hearing date scheduled in this matter and states the following:

1. On February 26, 2025, an Initial Telephonic Hearing Notice was sent to the parties, scheduling the hearing in this matter for April 15, 2025.
2. On March 10, 2025, a Prehearing Order for Telephonic Hearing was issued in this matter, directing that any party wishing to request a continuance for good cause submit a written motion at least five (5) days before the hearing and serve it upon the other party.
3. I&E’s primary witness is unavailable on Tuesday, April 15, 2025, the date of the currently scheduled hearing due to other Commission responsibilities.
4. On March 27, 2025, I&E contacted Mark Kotch (“Mr. Kotch”) of MK Hauling LLC via e-mail as a courtesy to inquire whether Respondent would consent to rescheduling the hearing in this matter.

5. The same day, March 27, 2025, Mr. Kotch responded via email that he “would rather not” reschedule. He stated that he wanted it to be “done and over with” but also indicated that he was waiting on his state representative’s office to see if the state representative would represent him in this matter.

6. In addition to accommodating the unavailability of I&E’s witness, a continuance in this matter would permit MK Hauling more time to obtain counsel and for its counsel to review the case, as well as to permit the Parties more time to potentially negotiate a settlement in this matter.

WHEREFORE, to accommodate I&E’s witness’ availability, as well as to afford more time for MK Hauling LLC to obtain counsel and for any counsel ultimately retained by Respondent to review the case or for the Parties to negotiate a potential settlement, I&E respectfully requests that the Initial Telephonic Hearing be continued.
