Consistent with Duquesne Light Company’s (“Duquesne Light” or the “Company”) Rider No. 1 – Retail Market Enhancement Surcharge (“RMES”) Annual Reconciliation filing dated January 30, 2025, at Docket No. M-2025-3053174, Duquesne Light files this letter in lieu of the supporting calculations for the Company’s RMES effective June 1, 2025. The Company’s RMES has remained at zero since an interim adjustment was permitted to become effective on February 1, 2022, at Docket No. M-2022-3030499.

The RMES shall remain in effect until otherwise directed by the Commission and until the final reconciliation statement is approved and charges fully recovered. Therefore, the remaining residual over collection balance of \$2,302 will be reflected as a regulatory liability in the event the RMES becomes active in the future.
