ORDER
DIRECTING FILING OF STATUS REPORT

On February 16, 2024, Ryan Flynn (“Mr. Flynn”) filed a Formal Complaint against the Pennsylvania American Water Company - Wastewater (“PAWC”) with the Pennsylvania Public Utility Commission (“Commission”). In his Complaint, Mr. Flynn complained of incorrect billing in relation to a mobile home park that he owns. The Complaint was served on PAWC on March 12, 2024.

On April 1, 2024, PAWC filed an Answer to the Complaint, admitting or denying the allegations of the Complaint.

Thereafter, hearings have been scheduled, and then cancelled and rescheduled, at the request of the parties four times.

On February 5, 2025, a Hearing Notice was issued scheduling this matter for an evidentiary hearing on April 3, 2025.

On March 27, 2025, PAWC informally through email made a request for continuance of the April 3, 2025 hearing, informing me that the parties were working on a resolution to this case, and that Mr. Flynn did not object to the request. I granted the continuance request informally through email.

On March 31, 2025, a Hearing Cancellation Notice was issued cancelling the April 3, 2025 hearing.

The evidentiary hearing will not be rescheduled at this time. Instead, I will direct the parties through this Order to file a Status Report in 60 days. The Status Report should propose the next procedural steps to be taken in this proceeding.

ORDER

THEREFORE,

IT IS ORDERED:

1. That the parties shall file a Joint Status Report **on or before May 30, 2025**, which proposes the next procedural steps to be taken in this proceeding.
