

**STATUS REPORT OF AQUA PENNSYLVANIA, INC.,**  
**THE OFFICE OF SMALL BUSINESS ADVOCATE,**  
**AND THE OFFICE OF CONSUMER ADVOCATE**

TO THE PENNSYLVANIA PUBLIC UTILITY COMMISSION:

Aqua Pennsylvania, Inc. (“Aqua” or the “Company”) submits the following Status Report to Administrative Law Judge Mark A. Hoyer (“ALJ”). Aqua has been authorized to present this Status Report on its behalf as well as on behalf of the Office of Small Business Advocate (“OSBA”) and the Office of Consumer Advocate (“OCA”) (“collectively the “Parties”).

**I. Introduction**

A Prehearing Conference Notice and Prehearing Conference Order were issued in this proceeding on August 29 and September 9, 2024, respectively, which scheduled a Prehearing Conference for September 30, 2024. Via email sent to the ALJ on September 9, 2024, the Parties requested that the Prehearing Conference be postponed to allow the Parties time to pursue settlement in this proceeding. The ALJ granted this request and the Prehearing Conference was canceled on September 16, 2024. On December 17, 2024, the ALJ emailed the Parties asking that the Parties provide him with a status report in this proceeding by January 7, 2025. The Parties submitted status reports on January 8 and February 28, 2025, which requested additional time to pursue settlement.

## **II. Status Report**

The Parties in this proceeding are continuing to progress toward the full settlement of this matter and are actively developing a term sheet for settlement. As such, the Parties respectfully request additional time to continue pursuing settlement and to provide another status report on April 30, 2025.

## **III. Conclusion**

WHEREFORE, Aqua Pennsylvania, Inc., the Office of Small Business Advocate, and the Office of Consumer Advocate hereby jointly request that the the Honorable Mark A. Hoyer accept this Status Report as the Parties continue to work toward settlement.
