HUNKS HAULING JUNK AND MOVING

In lieu of the applicable rates provided for in Tariff Freight Pa. P.U.C. No. 50 for the above carrier, the following hourly rates shall apply for shipments traveling from points in the counties of Berks, Bucks, Chester, Delaware, Montgomery and Northampton to points in Pennsylvania transported distances of forty (40) miles or less.

Subject to Notes AA and 1 to 3 below, the transportation charges on any shipment shall be a COMBINATION of the applicable TRAVELING CHARGE named in Column 1 plus HOURLY CHARGE at applicable rates named in Columns 2, 3 and 4.

NOTE 3 - When shipment needs to be held overnight for the convenience of the customer, an overnight holding fee of **\$250.00** per truck per night will apply in addition to all other applicable charges.
