Compliance Filing Regarding Tariff Review

Dear Secretary Chiavetta:

In its Opinion and Order entered in this matter on October 10, 2024, the Pennsylvania Public Utility Commission ("Commission") approved the Joint Petition for Approval of Settlement of Rate Proceeding ("Settlement") filed by Veolia Water Pennsylvania, Inc. ("VWPA"), the Bureau of Investigation and Enforcement ("I&E"), the Office of Consumer Advocate ("OCA"), the Office of Small Business Advocate ("OSBA"), and the Coalition for Affordable Utility Services and Energy Efficiency in Pennsylvania ("CAUSE-PA").

In pertinent part, the Settlement requires that VWPA initiate a comprehensive review of its tariff to ensure that the language and citations are consistent with applicable laws and the Commission's regulations. This review is to be initiated within 180 days of the effective date of rates in this case. Settlement ¶ 62.

This correspondence is to advise the Commission that VWPA has initiated the required comprehensive review of its tariff.
