**Methodology:** Verizon Long Distance LLC identified the revenue from mixed-use interstate private line services that are deemed interstate under the ten percent rule set forth in 47 CFR 36.154. Verizon Long Distance was not able to limit the revenues only to circuits that have physical facilities with a beginning and end point within Pennsylvania, and therefore included all revenue. Each of these services is provided under FCC tariffs and/or product guides and all of the revenue from these services is reported to the FCC as interstate for purposes of FCC assessments.

Under protest and subject to the objections set forth in its May 15, 2020 cover letter, Verizon Long Distance reports ten percent of the revenue from these services as "de facto gross intrastate operating revenues." Ten percent was determined to be a reasonable estimate of the de minimis amount of intrastate traffic on these interstate services, as discussed in the May 15, 2020 cover letter.
