This filing is a request for a **DECREASE** in local hourly rates on Sundays and Holidays.


The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

Subject to Notes AA, BB, and 1 to 5 below, the transportation charges on any shipment shall be a COMBINATION of the applicable TRAVELING CHARGE named in Column 1 plus HOURLY CHARGE at applicable rates named in Columns 2, 3 and 4.

NOTE 1 - Traveling charges (Column 1) are in addition to hourly rates (Columns 2, 3, and 4).

NOTE 2 - Hourly rates (Columns 2, 3, and 4) are based on the day or days as indicated, during which services are performed.

NOTE 3 - Hourly rates (Columns 2, 3, and 4) computed in half-hour (30 minutes) increments. Fractions of half-hour to be considered as one half-hour.

NOTE 4 - Charges for truck to be based on \$99.00 per day plus \$1.00 per total miles driven based on Google miles. When a 2nd and/or 3rd truck are required, the cost will be \$49.50 per day per truck plus \$1.00 per total miles driven per truck based on Google miles. When a support vehicle is required to transport team members and/or supplies to and from the job site, cost will be \$1.00 per total miles driven per support vehicle based on Google miles subject to a minimum charge of \$20.00 per support vehicle.

NOTE 5 - Carrier will add a 3% handling fee to the final charges when the customer chooses to pay with a credit card.

NOTE 6 - When BestDarnMovers is renting a vehicle on behalf of client, the client is responsible for the reimbursement of all actual charges assessed by the rental vehicle vendor, including fuel replacement, plus \$1.75 per mile on the mileage rate assessed by the rental vehicle vendor with a minimum reimbursement of actual cost + \$17.50. When Note 6 is applicable, charges shown in Note 4 will not apply. Mover will charge for the driver only at the rate shown for Driver in Columns 2, 3 or 4 above based on the day of the week service is performed.

NOTE AA - A flat charge based on one hour at the applicable transportation rates shown in Columns, 2, 3, and 4 apply if the road miles from the carrier's terminal to both the point of origin and point of destination are 20 miles or less.

NOTE BB - A flat charge based on two hours at the applicable transportation rates shown in Columns 2, 3, and 4 will apply if the road miles from the carrier's terminal to either the point of origin or the point of destination exceeds 20 miles.
