MOTOR CARRIER COMPLAINT

The Pennsylvania Public Utility Commission (“Commission” or “PUC”) is a duly constituted agency of the Commonwealth of Pennsylvania empowered to regulate public utilities within the Commonwealth. The Commission has delegated its authority to initiate proceedings which are prosecutory in nature to the Bureau of Investigation and Enforcement and other bureaus with enforcement responsibilities. Pursuant to that delegated authority and Section 701 of the Public Utility Code, the Bureau of Investigation and Enforcement – Motor Carrier Division hereby represents as follows:

1. That RUTLOV ENTERPRISES LLC, Respondent, maintains a principal address at 503 Governor Drive, Reading, PA 19607.
2. That on October 10, 2024, by Commission Secretarial letter, Respondent was issued a certificate of public convenience by this Commission authorizing transportation, as a common carrier, by motor vehicle, property, excluding household goods in use, between points in Pennsylvania at PUC utility code number 8927382, Docket No. A-2024-3050930.
3. That PUC Enforcement Officer David Drago was assigned to conduct a Safety Fitness Review (“SFR”) and began a series of attempts to contact the Respondent. Officer Drago, phoned leaving voicemails each time, texted and emailed the Respondent. On January 3, 2025, a letter was sent to Respondent’s principal address on file with the Commission by certified mail, asking the Respondent to contact the officer. Officer Drago again attempted to phone, text, and email the Respondent. To date, no contact has been made by the Respondent to these attempts.
4. That Respondent, by failing to respond to and achieve a satisfactory SFR evaluation while certificated by this Commission as a common carrier, violated 66 Pa. Code §§501(c) & 504. The penalty for these violations is cancellation of the certificate held by Respondent with this Commission at utility code number 8927382.

WHEREFORE, the Bureau of Investigation and Enforcement hereby requests that the Commission revoke the certificate of public convenience issued to RUTLOV ENTERPRISES LLC, at PUC utility code number 8927382.
