ORDER
DIRECTING THE FILING OF LATE-FILED EXHIBITS

On November 8, 2024, Arvella Love (“Ms. Love”) filed a Formal Complaint (“Complaint”) against PECO Energy Company – Electric (“PECO”) with the Pennsylvania Public Utility Commission, indicating that PECO has threatened to or has already terminated her service and requesting a payment arrangement. On December 3, 2024, PECO filed an Answer to the Complaint admitting or denying the allegations in the Complaint.

On March 21, 2025, the evidentiary hearing was held in this matter. Both parties were represented at the hearing and presented evidence on the issues raised. At the hearing, PECO agreed to file as late-filed exhibits Ms. Love’s account statement (Tr. 64-65) and meter test results (Tr. 70). Further at the hearing Ms. Love texted Attorney Khadijah Scott, representing PECO, a picture of her thermostat and Attorney Scott indicated that she would have PECO witness Vargas review the picture (Tr. 61-62).

Through this Order I will set a deadline for the submission of the above-mentioned late-filed exhibits, as I did not do so at the hearing. PECO is directed to submit late-filed exhibits of Ms. Love’s account statement, meter test results, and Mr. Vargas’s review of Ms. Love’s thermostat by **May 21, 2025**. Ms. Love may submit objections, if any, to the late-filed exhibits within 14 days of submission of the late-filed exhibits.

ORDER

THEREFORE,

IT IS ORDERED:

1. That PECO is to submit the late-filed exhibits referenced in this Order on or before **May 21, 2025**.

2. That Arvella Love may submit objections to PECO's late-filed exhibits, if any, within 14 days of the date of the submission of the late-filed exhibits by PECO.
