
The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from the final destination back to the carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest or TruckRouter.

0 - 20 miles	1 hour
21 - 40 miles	1 1/2 hours

◆ NOTE 3 - When other articles are deemed by the carrier to be bulky items are included in the shipment, a charge per bulky item in addition to all other applicable charges will apply as follows:

less than 200 pounds - \$150.00 200 pounds to 349 pounds - \$250.00 350 pounds & above - \$350.00

Carrier reserves the right to refuse transport of certain items due to size and weight.

NOTE 4 - When packing is requested or required, the container cost will be based on charges shown in Item 310 of Tristate 50-T and Item 115 of Tristate 51-W. Charges for packing and/or unpacking will be based on a flat fee of \$100.00 per vehicle used plus a cost of \$60.00 per hour for driver or additional packer. Packing/unpacking labor hours to be based on the total time from when the vehicle, driver and packer(s) leave the carrier's terminal until their return to the carrier's terminal at the completion of the job. Travel time to and from the job site may be calculated, in advance, using Mileage Guide No. 40 or computer software designed to calculate mileage and travel time such as Google Maps, MapQuest or TruckRouter.

NOTE 5 - LABOR RATE (Item 120) - Labor Rates shown for Lehigh County will apply for all counties within Pennsylvania.

NOTE 6 - ADDITIONAL TRANSPORTATION CHARGE (Item 160) - Rates shown under Schedule 2 will apply for all counties within Pennsylvania.

NOTE 7 - EXTRA PICKUP AND/OR DELIVERY (Item 230) - Rates shown under Schedule D will apply for all counties within Pennsylvania.
