**INTERIM ORDER
SETTING RESOLUTION CONFERENCE**

On or about March 5, 2025, Robin Rickman ("Complainant"), filed a Complaint against FirstEnergy Pennsylvania Electric Company and Energy Harbor LLC ("Respondent"), at the above-captioned docket number. On or about March 26, 2025, Respondent FirstEnergy Pennsylvania Electric Company filed an Answer to the Complaint. On or about March 27, 2025, Respondent FirstEnergy Pennsylvania Electric Company filed Amended Answers to the Complaint. On or about April 4, 2025, Respondent Energy Harbor LLC filed an Answer to the Complainant.

Based upon a review of the information contained in this material, I direct the parties to attempt to resolve this matter themselves. Respondent shall contact Complainant to set a mutually convenient date and time for Respondent and Complainant to hold a conference about resolving the case. The conference must take place no later than May 9, 2025, unless this is not possible.

Within ten (10) days following the conference, by May 19, 2025, Respondent shall file a short report with Mediator Teri-Lee Rhoades ("Mediator"), setting forth:

- (a) The date of the conference;
- (b) Who participated for each party;
- (c) A statement whether a full resolution, including withdrawal of Complaint, was achieved, and, if not, whether the parties consent to have this case set for mediation by the mediation staff of the Commission; and
- (d) A statement of any issues which have been resolved, if a full resolution was not achieved.
