You are directed upon receipt of this letter to publish the enclosed notice once a week for two consecutive weeks in a newspaper having a general circulation in the area involved and file proof of publication with the Commission on or before Monday, May 12, 2025.

This matter will receive the attention of the Commission and you will be advised of any further necessary procedure.


