MOTOR CARRIER COMPLAINT

The Pennsylvania Public Utility Commission (Commission or “PUC”) is a duly constituted agency of the Commonwealth of Pennsylvania empowered to regulate public utilities within the Commonwealth. The Commission has delegated its authority to initiate proceedings which are prosecutory in nature to the Bureau of Investigation and Enforcement and other bureaus with enforcement responsibilities. Pursuant to that delegated authority and Section 701 of the Public Utility Code, the Bureau of Investigation and Enforcement-Motor Carrier Division hereby represents as follows:

1. That Rasier – PA, LLC, Respondent, maintains its principal place of business at Uber 3 World Trade Center, 175 Greenwich Street, Floors 43-47, New York, New York, 10007.
2. That Respondent was issued a license by this Commission on January 26, 2017, at Application Docket No. A-2016-2580821, authorizing transportation of persons for compensation in Transportation Network Company service.
3. That Respondent, on February 12, 2025, permitted a certain 2021 Tesla Model 3 bearing WA registration number CNK1649 and having Vehicle Identification No. ending in the last 4 digits 1502 to be operated by driver Erhan Sengun.
4. That the vehicle described in numbered paragraph 3, above, was inspected on that date by PUC Motor Carrier Enforcement Supervisor Ryan Balestra at the Pittsburgh International Airport, Coraopolis, Allegheny County. The vehicle did not have a valid Pennsylvania Department of Transportation (“PennDOT”) certificate of inspection.
5. That Respondent, by allowing a vehicle to operate while not having a valid PennDOT certificate of inspection onboard the vehicle, has violated 52 Pa. Code §29.405 and 66 Pa.C.S. §2606(c). The penalty for this violation is \$250.

WHEREFORE, the Bureau of Investigation and Enforcement hereby requests that the Commission fine Rasier - PA, LLC, the sum of two hundred fifty dollars (\$250.00) for the illegal activity described in this Complaint and order such other remedy as the Commission may deem to be appropriate.
