Dear Ms. Roth,

Please find attached individual tariff, Freight Pa. P.U.C. No. 15, effective May 19th, 2025 (this tariff cancels Freight Pa. P.U.C. No. 14) for Fischer-Hughes Transport, Inc. (PA PUC Certificate #A-00103976), 1180 Church Road, Suite 500, Lansdale PA 19446.

Changes to this tariff are and **INCREASE** to Peak Season labor charge under Item 50; a **CHANGE** in the packing & unpacking service under Item 70; a **CHANGE** in Full Value Replacement Protection under Item 80; an **INCREASE** in container rates, a **DECREASE** in packing straight time and the **ADDITION** of packing overtime under Item 250; and an **INCREASE** in local hourly rates (both Non-Peak Season and Peak Season) under Item 300.



SECTION 1
RULES & REGULATIONS

ITEM 10 - SCOPE OF CARRIER'S OPERATING AUTHORITY

Carrier is authorized to transport household goods, in use, between points in Pennsylvania.

ITEM 20 - GOVERNING PUBLICATIONS

Except as otherwise provided herein for rates, rules, regulations and provisions applicable to the transportation of household goods, in use, see Tariff Freight Pa. P.U.C. No. 53 (Carrier Directory), revisions thereto and reissues thereof, issued by Tristate Household Goods Tariff Conference, Inc., Agent.

ITEM 30 - DECLARED VALUE

Rates and charges named herein applicable when value declared by shipper does not exceed sixty (60) cents per pound, per article (see Governing Tariff).

Item 40 - PIANO CARRY

When a baby grand or grand piano is included in the move an additional charge of **\$50.00** will be assessed.

ITEM 50 - LABOR CHARGE

Carrier will assess a charge of **\$49.00** per hour (Non-Peak Season) and **◆ \$53.00** per hour (Peak Season) for labor charges when no other charges are otherwise provided in this tariff, when such services are requested by shipper or his agent.

ITEM 60 - CLASSIFICATION OF PROPERTY

Class 1 shipments are personal effects and property used or to be used in a dwelling when a part of the equipment or supply of each dwelling and such other similar property; except that this subparagraph shall not be construed to include property moving from a factory or store, except such property as the householder has purchased with the intent to use in his dwelling and which is transported at the request of the householder and the transportation charges paid to the carrier by the householder.

▲ ITEM 70 - PACKING AND UNPACKING SERVICE

When packing is performed per unit, rates in **Item 250** on Page 5 will apply. When packing and/or unpacking is performed by the hour, hourly rates shown in **Item 300** on Pages 6 and 7. Regular time and overtime charges will apply for both packing and unpacking as applicable.

ITEM 75 - PAYMENT

This carrier may elect to accept MasterCard or Visa credit cards as payment for all rates and charges, subject to the following notes below.

NOTE 1 - The application of this item is subject to authorization from MasterCard, Visa or American Express on each individual shipment.

NOTE 2 - This item will only apply to shipments transported between points in Pennsylvania.

NOTE 3 - Carrier reserves the right to add **4%** to the final charges when the customer chooses to pay with a credit card.

ITEM 80 - FULL VALUE REPLACEMENT PROTECTION

Provisions of this rule will apply on the transportation of household goods, in use, between points in Pennsylvania for both shipments transported forty (40) miles and less and shipments transported in excess of forty (40) miles.

▲ Full Value Protection will be provided by carrier only if shipment is declared at a minimum lump sum of **\$10,000.00** or **\$6.00** for each pound of weight in the shipment, whichever is greater.

The minimum is computed by multiplying the estimated weight of **\$6.00** for each pound of weight in the shipment or **\$10,000.00**, whichever is greater.

RULES & REGULATIONS

ITEM 85 - PICKUP OR DELIVERY TRANSPORTATION RATES ON STORAGE-IN-TRANSIT

(a) Apply hourly rates shown in **Item 300** herein. Minimum transportation charge eight (8) hours at rates named in Column 1 and Columns 2, 3 and 4 in **Item 300** herein. Hourly rates apply on loading, actual movement or transportation and unloading (except as provided in (b) below).

(b) Where storage-in-transit shipment is not unloaded at carrier's warehouse and shipment remains on carrier's vehicle, an overnight S.I.T. flat charge of **\$150.00** per vehicle will be assessed.

(c) Waiting charge will be assessed by carrier on the basis of a vehicle, driver and two helpers at the applicable hourly rates shown in **Item 300** from 8:00AM following overnight S.I.T. flat charge until carrier's employees and equipment arrive at the customer's location for unloading. Thereafter, carrier's hourly rates in **Item 300** will be assessed on the equipment and labor furnished by carrier from the commencement of unloading and dismissal of equipment and labor by shipper.

ITEM 90 - WAIVER OF MINIMUM CHARGE

When move is performed solely at the carrier's convenience, carrier shall not assess a minimum transportation charge. In such instances, carrier shall charge based on the actual time to complete the move plus the applicable travel time charge.

ITEM 95 - Cancellation Fee

On jobs cancelling less than two business days before the scheduled start time, carrier reserves the right to charge a cancellation fee of **10%** of the total estimated cost of the move.

ITEM 100 - Booking Commissions

On jobs booked for the privilege of a third party relocation company or foreign agent, carrier will implement a **20%** booking commission on the linehaul.

Container charges and materials which remain the property of the consignee. Charges for containers & packing labor in dollars and cents.

SECTION 3
HOURLY RATES

ITEM 300

Applicable on transportation of Class 1 Shipments (Item 60) transported distances of forty (40) miles or less.

Subject to Notes 1 to 6 below. The transportation charges on any shipment shall be a combination of the applicable traveling charge named in Column 1 plus hourly charge at applicable rates named in Columns 2, 3 and 4.

Hourly rates apply only from time of arrival of vehicles and men at first point of origin (continue during all loading, transportation from first point of origin to final destination and unloading) until completion of unloading and dismissal of vehicles and men by shipper at destination.

Traveling charges cover traveling to first point of origin and traveling from final destination, irrespective of the actual time involved in such traveling.

- NOTE 6 - Travel time for each day shall be charged on the applicable hourly rates based on the sum of the miles from carrier's terminal to job site plus job site back to carrier's terminal:

0 to 15 miles - 1 hour

One-half hour for each additional 15 miles increment or fraction thereof.

Mileage to be determined by Google Maps - Zip Code to Zip Code.

* When requested by shipper. If the move is performed after-hours (any time other than Weekdays - 7:01AM to 5:00PM) solely at the carrier's convenience, carrier shall base charges on the Weekday Rates (7:01AM to 5PM) in Column 3.

ITEM 300

Applicable on transportation of Class 1 Shipments (Item 60) transported distances of forty (40) miles or less.

Subject to Notes 1 to 6 below. The transportation charges on any shipment shall be a combination of the applicable traveling charge named in Column 1 plus hourly charge at applicable rates named in Columns 2, 3 and 4.

Hourly rates apply only from time of arrival of vehicles and men at first point of origin (continue during all loading, transportation from first point of origin to final destination and unloading) until completion of unloading and dismissal of vehicles and men by shipper at destination.

Traveling charges cover traveling to first point of origin and traveling from final destination, irrespective of the actual time involved in such traveling.
