When vehicle provided is greater than 24 feet in length, an additional **\$10.00** per hour shall apply for each vehicle provided.

NOTE 1 - MINIMUM TRANSPORTATION CHARGES: Sundays and Holidays (any hour): 8 hours at rates named in Columns 1 and 2. Saturday (any hour) and Weekdays(5:01PM to 7:00AM): 8 hours at rates named in Columns 1 and 4. Weekdays (7:01AM to 5PM): 8 hours at rates named in Columns 1 and 3. When move is performed solely at carrier's convenience, carrier shall not assess a minimum transportation charge. In such instances, carrier shall charge based on the actual time to complete the move plus the applicable travel time charge.

NOTE 2 - Rates in Column 4 apply only from 5:01PM to 12:00 Midnight on any day when a higher rate is shown for the following day.

NOTE 3 - When a baby grand or grand piano is included in the move, an additional charge of **\$50.00** will be assessed.

NOTE AA - TRAVEL TIME: Travel time for each day shall be charged on the applicable hourly rate based on the total miles from carrier's terminal to the job site (first point of origin) and from the job site (final destination) back to carrier's terminal.

1 to 25 miles - 1 hour travel time

One-half hour for each additional 25 miles increment or fraction thereof.

Mileage to be determined by Google Maps - Zip Code to Zip Code.

In lieu of the applicable rates provided for in Tristate 50-T and Tristate 51-W for the above carrier, the following assessorial rates shall apply for shipments traveling between points in Pennsylvania and transported distances over forty (40) miles.

▲ NOTE 1 - When shipment is held overnight for the convenience of the customer, a flat fee of **\$150.00** per truck per night will apply.

▲ NOTE 2 - Cancellation Fee: On jobs cancelling less than two business days before the scheduled start time of the move, carrier reserves the right to charge a cancellation fee of **10%** of the total estimated cost of the move.

▲ NOTE 3 - Credit Card Fee: A **4%** fee will be charged when customers choose to pay with a credit card.
