
Dear Special Agent Mroczka:

Hudson Energy Services, LLC ("Hudson") does not oppose Clovernote's April 9, 2025, letter-request for a 20-day period, commencing at the time an extension of time is granted, to respond to previously filed New Matters submitted by Hudson and Duquesne Light Company ("Duquesne").

However, Hudson wishes to note that a new 20-day Answer period commencing at some time in the future to respond to the New Matters will require cancellation of the scheduled May 9, 2025 hearing date. 
