
The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

CANCELLATION FEE

Weleski Transfer, Inc. reserves the right to charge cancellation fees in the following amounts:

On jobs cancelling within twenty-four (24) hours of scheduled start time, shipper will be charged two (2) hours for labor and equipment at the estimated hourly rates.

On jobs cancelling less than forty-eight (48) but not more than twenty-four (24) hours of scheduled start time, shipper will be charged one (1) hour for labor and equipment at the estimated hourly rates.

BOOKING COMMISSIONS

Weleski Transfer, Inc. requests the permission to implement a 20% booking commission on the line haul portion of all Intrastate PA shipments moving in excess of forty (40) miles that are booked for the privilege of a third party relocation company and/or Intrastate PA move requests of over forty (40) miles made by a foreign agent. This additional booking commission will not be levied upon any shipment sold by and booked by the Weleski Transfer, Inc. sales force.

PACKING/UNPACKING LABOR RATES (Item 110)

In lieu of packing/unpacking labor rates named in Tristate 51-W, Schedule D rates will apply for packing at all points within Pennsylvania.

LABOR RATES (Item 120)

Labor Rates for Allegheny County will be applicable for all points within Pennsylvania.

STORAGE-IN-TRANSIT (Item 200)

First day storage rates, each additional day storage rates, warehouse handling charges for Allegheny County will be applicable for all points within Pennsylvania. The schedule assigned to Allegheny County in Section 3 will be used for pickup and delivery transportation rates of Storage-In-Transit shipments at all points within Pennsylvania.

▲ INTRASTATE TRANSPORTATION CHARGE (Section 2 - Transportation Rate Schedule A)

Carrier waives Peak Season transportation rates on Page 58-B in Tristate 51-W. Non-Peak Season transportation rates shown on Page 58 of Tristate 51-W will be used by the carrier year-round.
