Application of South Whitehall Township for approval of the alteration of the public crossing (DOT 591 377 F) where Eck Road crosses, at grade, the track of Norfolk Southern Railway Company located in South Whitehall Township, Lehigh County

To Whom It May Concern:

By Amended Secretarial Letter dated November 1, 2022, we directed the alteration of crossing (DOT 591 377 F) where Eck Road crosses, at grade, the track of Norfolk Southern Railway Company located in South Whitehall Township, Lehigh County. All work at the subject crossing was to be completed on or before June 30, 2023.

In a previous letter petition received on January 15, 2024, Langan Engineering and Environmental Services, Inc. (Langan) on behalf of South Whitehall Township requested the Commission extend the completion date. The letter petition was granted by a Secretarial Letter dated January 24, 2024, extending the completion date to January 31, 2025.

In the current request, received via letter petition on March 28, 2025, Langan on behalf of South Whitehall Township requests a further time extension with a new completion date of October 31, 2025, due to additional time needed by other reviewing agencies.

We have carefully reviewed the record in this proceeding and will grant South Whitehall Township an extension of time to October 31, 2025.

THEREFORE:

The letter-petition received on March 28, 2025, by Langan Engineering and Environmental Services Inc. on behalf of South Whitehall Township be and is hereby granted to the extent herein directed:

1. Paragraph 16 of the amended Secretarial Letter dated November 1, 2022, modified on January 24, 2024, which reads as follows, to wit:

“16. The alteration of the crossing be completed on or before January 31, 2025, and that on or before said date, South Whitehall Township report to this Commission in writing the actual date of completion of the work.”

be and is hereby modified to read:

16. The alteration of the crossing be completed on or before October 31, 2025, and that on or before said date, South Whitehall Township report to this Commission in writing the actual date of completion of the work.

2. In all respects not inconsistent herewith, our Secretarial Letter dated November 1, 2022 remain in full force and effect.

The parties are reminded that failure to comply with this or any Order or Secretarial Letter in this proceeding may result in an enforcement action seeking civil penalties and/or other sanctions pursuant to Public Utility Code 66 Pa. C.S. §3301.



If your filing contains confidential material, you are required to file by overnight delivery to ensure the timely filing of your submission. There are certain filings that cannot be eFiled, such as filings containing confidential or proprietary material. These must be submitted to the Secretary by overnight delivery, priority, or certified mail to allow tracking of your filing.

If you are dissatisfied with the resolution of this matter, you may, as set forth in 52 Pa. Code §§ 1.31 and 5.44, file a Petition for Reconsideration from Staff Action (Petition) with the Commission within twenty (20) days of the date of this letter. The Petition shall be eFiled with the Secretary of the Commission or sent to: Secretary, PA Public Utility Commission, 400 North Street, Harrisburg, PA 17120, and must be filed within twenty (20) days, or if no timely request is made, the action will be deemed to be a final action of the Commission.

The Petition MUST include: (1) a written statement (divided into numbered paragraphs) outlining the reasons for the request; (2) the case docket number (it is provided for you at the top right-hand corner of this letter); (3) the party on whose behalf the petition is made; (4) a Certificate of Service on the other parties of record; and (5) a Verification with original signature in accordance with 52 Pa. Code § 1.36.
