**INTERIM ORDER
SETTING RESOLUTION CONFERENCE**

On or about March 21, 2025, Joseph Zinobile ("Complainant") filed a Complaint against PPL Electric Utilities Corporation ("Respondent"), at the above-captioned docket number. On or about April 10, 2025, PPL Electric Utilities Corporation, Respondent filed an Answer to the Complaint.

Based upon a review of the information contained in this material, I direct the parties to attempt to resolve this matter themselves. Respondent shall contact Complainant to set a mutually convenient date and time for Respondent and Complainant to hold a conference about resolving the case. The conference must take place no later than May 19, 2025, unless this is not possible.

Within ten (10) days following the conference, Respondent shall file a short report with Mediator Cynthia Lehman ("Mediator"), setting forth:

- (a) The date of the conference.
- (b) Who participated in each party.
- (c) A statement whether a full resolution, including withdrawal of Complaint, was achieved, and, if not, whether the party's consent to have this case set for mediation by the mediation staff of the Commission; and
- (d) A statement of any issues which have been resolved if a full resolution was not achieved.

If it is not possible to have the conference by the date set for that purpose, Respondent shall file a report with the Mediator, on or before ten (10) days following the conference due date, giving the reason(s) why the due date could not be met.
