This filing is a request for an **INCREASE** in local hourly rates.


The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

In lieu of the applicable rates provided for in Tariff Freight Pa. P.U.C. No. 50 for the above carrier, the following hourly rates shall apply for shipments traveling between points in Pennsylvania and transported distances of forty (40) miles and less.

Subject to Notes 1 to 11 below, the transportation charges on any shipment shall be a COMBINATION of the applicable TRAVELING CHARGE (see Note 1 below) plus HOURLY CHARGE at applicable rates named in Columns 1, 2, and 3.

NOTE 3 - Hourly rates (Columns 1, 2, and 3) computed in quarter-hour periods; fractions of one-quarter hour considered as one-quarter hour.

NOTE 4 - Minimum Transportation Charge: Sundays and Holidays (any hour): 6 hours at rates named in Column 3 plus applicable travel time charge. Fridays & Saturdays (any hour) or Mondays - Thursdays (any hour): 1 hour at rates named in Columns 1 or 2 plus applicable travel time charge.
