Thank you so very, very, much, for reviewing the evidence that was ignored before. As far as me not appealing the decision of the second judge that totally reversed my monetary win, it was solely because it was stated that I was only allowed to submit 25 sheets of evidence. He knew that I won because I was able to prove my case with the submission of over 300 sheets of evidence. It was like he was letting me know he did not care to hear the evidence and had already ruled against me.

The PUC should do what it stands for. I also discovered that my lawyer, George Gossett miscalculated the amount of money I paid to Peco by phone as \$5,000.00-6,000.00 when in fact the amount was over \$20,000.00. When I took the time to go over everything my lawyer did, I found that he did not add all the phone payments correctly and the phone payments alone totaled \$20,938.88 (Nov.25, 2018- Feb. 6, 2020).

I went to Peco on Market St and supervisor Ms. Korryne forced me into a 6-month payment agreement of an extra \$500.00 additional to my house bill while they "investigated the meters at 6901 N. 17th St. I paid. The bills show the transferer of bills and forced payment agreement. Never got any results from the "investigation, and July 2019, 2 weeks after paying the agreement in full, I get a call from a PECO representative saying I owe another \$3,000.00 in old bills. I tried to explain that I had just paid \$3,000.00 of mis bills while waiting on an investigation that was never completed to my knowledge and I was not going to keep paying \$3,000.00 every 6 months, I did not owe. This has caused great problems for me financially, hampering business procedures and growth, harming my credit, stressing my mental and physical health. I have given all the proof needed for anyone to see there has to be a mistake in billing, and yet, from July 2019 to present my proof, receipts, checks, phone payments and all documentation I have given, has been ignored, suppressed & disrespected as if I am second class citizen. My civil rights and liberties have been violated repeatedly by PECO's law team/representative as if there was a personal issue with me daring to fight for the truth. I wasn't trying to not pay. I was trying to inform PECO of the mis-billing and over charges placed on me. My home, businesses, and properties have been refused service, service cut off, embarrassed, shamed in the middle of cold weather and Aug. 2024, two days no electricity that took a dr. note because of stress & health issues caused by the stress, to get my power turned back on. I saved every cut off letter each time service was cut off.

Six years I have had to shoulder this burden while my property taxes increase astronomically, my storm water bill has been mis-billed and is greater than the property taxes on this same building. My property insurance has increased over 300%. Its like my building I worked hard for is on someone's list of small blk landlords to destroy and force to sell their generational wealth. I should not have to fight this hard to keep what I worked for. To see a blk female lawyer treat me with so much disrespect and distain is hurtful on so many levels. All I want is what is rightfully mine. I worked hard for it. My kids deserve this little piece of the American pie/dream.... Nightmare.

I want to be monetarily compensated for all the damage, inconvenience, harm, embarrassment and stress done to me, my businesses, my liberties and my civil rights.


