Dear Mr. Salamone:

On March 3, 2025, the Pennsylvania Public Utility Commission (Commission) received Renewable Strategy Partners Inc.'s Application for an Electric Generation Supplier (EGS) license.

The applicant stated throughout its EGS Application Package that the name of the applicant is "Jamp Management Inc." According to the applicant's PA Department of State registered name, the name must be written as "Renewable Strategy Partners Inc." All instances of this error must be corrected throughout the EGS Application Package.

In order for the Commission to accept the Application for review, these deficiencies must be corrected. Failure to respond timely will result in the Application being deemed rejected<sup>1</sup> and the docket will be closed.

Please use the Commission's efilng system or an overnight delivery service to submit the requested information to the Secretary of the Commission **within 14 days** from the date of this letter. Please submit revised Application pages for each section. The Commission accepts all public documents through our efilng system and strongly recommends companies open an efilng account through the Commission's website at <https://efiling.puc.pa.gov>. Use of the efilng system will ensure that submissions by the company are received timely and receipt can be verified.

If your filing contains confidential material, you are required to either file by overnight delivery or submit to the Secretary's SharePoint File system to ensure the timely filing of your submission. Filers should contact the Secretary's Bureau in advance to gain access to the
