





Applications of **American Wholesale Energy Inc.** for Approval to Offer, Render, Furnish or Supply Natural Gas Supply Services at Docket No. **A-2024-3050943** and Electricity or Electric Generation Services at Docket No. **A-2024-3052394** to the public in The Commonwealth of Pennsylvania.

**American Wholesale Energy Inc.** has filed an application with the Pennsylvania Public Utility Commission ("PUC") for a license to provide natural gas supply services as (1) a **supplier or aggregator of natural gas services** or (2) a **broker/marketer engaged in the business of supplying natural gas services**. **Additionally, American Wholesale Energy Inc.** has filed an application with the PUC for a license to supply electricity or electric generation services as (1) a **supplier of electricity**, (2) a **broker/marketer engaged in the business of supplying electricity services**, or (3) an **aggregator engaged in the business of supplying electricity**. **American Wholesale Energy Inc.** proposes to sell electricity, natural gas, and related services in the entire Commonwealth of PA under the provisions of the Natural Gas Choice and Competition Act and the Electricity Generation Customer Choice and Competition Act

The PUC may consider this application without a hearing. Protests directed to the technical or financial fitness of **American Wholesale Energy Inc.** may be filed within 15 days of the date of this notice with the Secretary of the PUC, 400 North Street, Harrisburg, PA 17120. Please include the respective NGS or EGS Docket Nos. above on the protest.
