FAILURE TO APPEAR. If you do not take part in this prehearing conference, without showing good cause, your complaint or defenses may be dismissed. Also, you will waive any objections to matters agreed on at the prehearing conference and any rulings and orders with respect to those matters.

CONTINUANCES. You may request a continuance of the hearing if you have a good reason. All continuances will be granted only for good cause. To request a continuance, you must submit a written request (a “motion”) at least five (5) days before the hearing. Your motion should include: 1) The case name, number, and hearing date; 2) The reason for the request; and 3) Whether the other party agrees (or if you do not know).

ACCOMMODATION. If you require an interpreter to participate in the conference, we will make every reasonable effort to have an interpreter present. Please call the scheduling office at the Public Utility Commission at least ten (10) business days prior to your hearing to submit your request.
