PECO objects to the Complainant's second continuance request. The Prehearing Order dated December 2, 2024 stated:

**You must call into the hearing on the scheduled day and time. If you fail to do so, your case will be dismissed. You will not be called by the Administrative Law Judge.**

The Complainant had ample opportunity to advise PECO or the Court of a need for a second continuance prior to the hearing. The Complainant could have dialed into the hearing and advised that she was ill and needed a continuance, as I have had other Complainants do with Covid-19 in the past. The Complainant could have had someone advise PECO or the Court on her behalf prior to the hearing.
