**NOTIFICATION OF PROPOSED CONSTRUCTION**

Pursuant to the requirements of 52 Pa. Code § 59.38, National Fuel Gas Distribution Corporation (“National Fuel”), hereby files the following Notification of Proposed Construction:

1.     Description and Location of Proposed Work. National Fuel is planning to install approximately 5,100’ of 4” plastic pipeline, and 750’ of 2” plastic pipeline along S. Keel Ridge Road between Spencer Road and S. Neshannock Road in the City of Hermitage, Mercer County, PA. The project will be constructed by a National Fuel approved contractor.
2.     Type of Facility. Installation of 4” plastic and 2” plastic gas facilities.
3.     Estimated Starting Date. Construction is expected to begin on or about June 16<sup>th</sup>, 2025.
4.     Estimated Completion Date. Construction is expected to be completed by September 30<sup>th</sup>, 2025.
5.     Design Pressure. The pipeline will be designed for a maximum allowable operating pressure of 60 psig.
6.     Estimated Cost. The cost of the pipeline project is \$360,000.

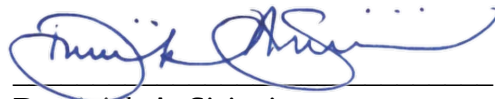

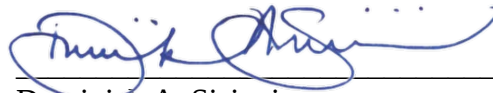
