1. Complainant filed the Complaint in the above-referenced matter against Peoples Natural Gas Company LLC ("Peoples") on April 14, 2025.
2. The primary allegations of the complaint appear to involve the natural gas supply charges that were assessed to Complainant's account.
3. The account Complainant has filed a complaint about had Major Energy Services, LLC or its predecessor as the natural gas supplier since 2019.
4. Peoples' records further indicate that the company was requested to remove Major Energy Services LLC as the natural gas supplier effective February 18, 2025.
5. The disputed balance for which Complainant seeks to have a 25% discount applied to was stated in the complaint as being for the natural gas supplier balance.
6. Major Energy Services, LLC is a separate and distinct company from Peoples to which Peoples has no affiliation.
7. Major Energy Services, LLC should be joined as an indispensable party to this matter.
