RULES & REGULATIONS

1. Advance reservations are required and must be made 72 Hours prior to service being rendered. Any reservation made less than 72 Hours to travel time will be charged an additional fee.
2. Point to Point Service: Pick-Up Charges commence when the vehicle arrives at the initial pickup location and conclude at the final drop-off location.
3. Additional expenses necessitated by or incurred at the request of the passengers, including but not limited to, highway tolls, bridge tolls, entrance fees and parking, shall be added to the charge of the trip. Expenses for driver's lodging and meals while on trips out of town which are in excess of ten (10) hours will be added to the basic charge.
4. Trips on the following Holidays are subject to Additional fees as listed in RATES:
 - New Year's Eve and New Year's Day
 - Memorial Day
 - Independence Day
 - Labor Day
 - Thanksgiving Day and Black Friday (Day after Thanksgiving)
 - Christmas Eve and Christmas Day
5. All invoices include a 20% Gratuity.
6. All invoices include a 20% Service fee to cover fuel, app, tolls, cleaning, and booking/processing
7. Promotional Fares / Discounts: Upon presentation of an advertised coupon or other special promotional offer, carrier will offer rates at a specified discount from the published tariff rates on the dates authorized by the coupon or offer. Advertised coupons or other special offers will be filed with the PA Public Utility Commission prior to publication or broadcast in one or more of the following: local newspapers, radio and television advertising, flyers, postcards, or other printed media, and the Internet.
8. All reservations must be paid in full at the time of booking
9. Cancellations within 72 Hours of scheduled pickup time will result in a 100% fare forfeiture.
10. Cancellations made more than 72 hours in advance are subject to a 35% cancellation fee.

SCHEDULE OF RATES

Reservations: Any Reservation made less than 72 hours before travel time will be charged an additional \$100.00 fee.

Hourly Rates: – Minimum charged will be for 4 hours, or any fraction thereof. Additional time will be charged in 1 hour increments, or any fraction thereof, at the following rates:

Mileage Based Rate applies to “Point to point based service” from 1 designated point to another designated point for example from home to the airport. In this case, a 4-hour minimum **does not apply**. There is a flat fee of \$99.00 to cover the first 0-15 miles. Every additional mile will cost \$3.71.

Standard Hourly Rate (4hr min): 7:00 AM to 10:00 PM

Luxury SUV	\$99.00/Hour
Additional 1 hour, or any fraction thereof:	\$99.00/Hour

Standard Overnight Hourly Rate (4hr min.): 10:00 PM to 7:00 AM + a \$50.00 Flat Fee

Luxury SUV:	\$99.00/Hour
Additional 1 Hour, or any fraction thereof:	\$99.00/Hour

Point-to-Point Service (4hr min. does not apply) Example: Airport Transfer

Luxury SUV	\$99.00 Flat for 0 -15 Miles
Each additional mile	+\$3.71 / per additional mile

Additional Charges

- Child Safety Seats: \$25.00 per seat (Upon request)
- Airport/ Seaport Pickups: \$25.00 Surcharge
- Wait Time: \$25.00 per 15-Minute increment (After a 15-Minute Grace Period)
- Holiday Surcharge: \$50.00 Surcharge on Major Holidays
