**To Pre-register By Phone** - Please call Judge Watson's office at 412-565-3550 and leave a message providing: (1) your first and last name, (2) the date and time of the hearing at which you wish to testify, (3) the phone number you will be using to call into the public input hearing, (4) a phone number where you can be reached prior to the hearing if we need to contact you, (5) your email address, if you have one, and (6) if you require an interpreter to participate in the hearing, the language of the interpreter. Please note, if you require an interpreter to participate in a hearing, every reasonable effort will be made to have an interpreter present. If you intend to be a witness and offer any exhibits at a telephone public input hearing, you must email your proposed exhibit(s) to the Administrative Law Judges by 10:00 a.m. the day before the Public Input Hearing at which you seek to testify at a telephonic public input hearing. Please email your exhibits to [jeffwatson@pa.gov](mailto:jeffwatson@pa.gov), and [callenswor@pa.gov](mailto:callenswor@pa.gov), and to their legal assistant at [mwarnar@pa.gov](mailto:mwarnar@pa.gov). Your proposed exhibits must be submitted in a form acceptable for admission into the record by the Commission Secretary and must be received timely by the Administrative Law Judges and legal assistant with attachments that are properly uploaded and readily able to be opened, viewed and transferred to the active Parties. The proposed exhibits will be forwarded by

the office of Administrative Law Judge electronically to counsel for the active parties. The exhibits should not include any personal or confidential information as they will be provided to all of the active parties in this case. The proposed exhibits may not be considered in the event of the failure to comply with the requirements set forth in this Notice or if they are not received by the Judges and Legal Assistant by Tuesday, June 3, 2025, not later than 10:00 AM.
