1. LEGAL AUTHORITY

This subpoena is issued pursuant to 52 Pa. Code § 5.421 and the Rules of Practice and Procedure of the Pennsylvania Public Utility Commission (PUC). The undersigned Complainant respectfully demands the production of the below-identified documents and records relevant to Docket proceedings before the Commission. The Administrative Law Judge presiding over this matter has authority to enforce this subpoena and may issue sanctions for failure to comply.

2. DOCUMENTS AND RECORDS REQUESTED

1. The full HARD FILE related to the account of Shasta-Patrice Brown, including all original applications, internal communications, revisions, customer service notes, amendments, and attachments.
2. All IOLTA (Interest on Lawyers' Trust Account) records involving transactions, settlement funds, or escrow connected to the account.
3. All SUB-ACCOUNTS and NESTING ACCOUNTS maintained under or behind the main account, including deferred liabilities, credits, or internal classifications.
4. OFF-BALANCE SHEET LEDGERS, trial balances, and all accounting entries made outside of GAAP reports or formal financial statements.

5. GENERAL LEDGER and JOURNAL ENTRIES reflecting internal charges, credits, accounting adjustments, and trust-based accruals.
6. All DEPOSIT RECORDS tied to account activity, including third-party deposits, payments held in suspense, or unapplied balances.
7. Any CUSIP numbers or security identification designations connected to securitization of the account or bundled receivables.
8. Records showing whether the account is treated as an ASSET or LIABILITY internally or in any investor-facing documentation.
9. All documents or filings with the SEC, FERC, or internal policy defining customer accounts as investor-based or interest-yielding positions.
10. All IRS and Treasury records including but not limited to: 1099, Form 56, 8300, 233, 231, etc.

3. RELEVANCE AND NECESSITY

These records are material to determine the accounting and legal treatment of Complainant's account, including potential fiduciary misrepresentation, investor rights, billing error, unjust enrichment, and trust violations. This request seeks to identify whether Complainant's account has been securitized, collateralized, or improperly withheld from financial reconciliation and crediting under public trust standards.

4. DELIVERY INSTRUCTIONS

You are hereby instructed to produce the above-requested documents within 10 days of service of this subpoena, or by such date as the presiding Administrative Law Judge may order. Documents should be delivered via email to the Complainant or by certified mail to the service address on record. Originals should be made available for in-person inspection if so requested.
