

## NOTICE OF MOTOR CARRIER COMPLAINT

- A. You must file an Answer within twenty (20) days of the date of service of this Complaint. The date of service is the mailing date as indicated at the top of the Secretarial Cover Letter for this Complaint and Notice, 52 Pa. Code §1.56(a). An Answer is a written explanation of circumstances wished to be considered in determining the outcome. The Answer should raise all factual and legal arguments that you wish to claim in your defense and must include the reference number of this Complaint. Your Answer must be verified and the original **mailed to:**

- B. If you fail to answer this Complaint within twenty (20) days, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a penalty. The penalty could include a fine, the suspension or revocation of your certificate of public convenience, or other such remedy.
- C. You may elect not to contest this Complaint by paying the fine proposed in this Complaint by certified check or money order. **Payment must be made to "Commonwealth of Pennsylvania"** and forwarded to:

- D. Your payment is an admission that you committed the alleged violation and an agreement to cease and desist from further violations. Upon receipt of your payment, the Complaint proceeding shall be closed.
- E. If you file an Answer, which admits or fails to deny the allegations of the Complaint, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a fine and/or other such remedy.
- F. If you file an Answer which contests the Complaint, the matter will be assigned to an Administrative Law Judge (ALJ) for hearing and decision. The ALJ is not bound by the optional fine set forth above.

COMPLAINT

The Pennsylvania Public Utility Commission (Commission or “PUC”) is a duly constituted agency of the Commonwealth of Pennsylvania empowered to regulate public utilities within the Commonwealth. The Commission has delegated its authority to initiate proceedings which are prosecutory in nature to the Bureau of Investigation and Enforcement and other bureaus with enforcement responsibilities. Pursuant to that delegated authority and Section 701 of the Public Utility Code, the Bureau of Investigation and Enforcement-Motor Carrier Division hereby represents as follows:

1. That G5 TAXI INC, Respondent, maintains its principal place of business at 100 North Wilkes-Barre Blvd, Ste 302, Wilkes-Barre, Luzerne County, Pennsylvania, 18703.
2. That Respondent was issued a certificate of public convenience to transport, as a common carrier, by motor vehicle, persons in call or demand service between points in Lackawanna and Luzerne Counties, to points in Pennsylvania and return by this Commission on October 5, 2023, at PUC No. A-6325884, Docket No. A-2023-3037749.
3. That on April 14, 2025, PUC Enforcement Officer Elliott Miller conducted a random inspection on Hanover Street, Wilkes-Barre, PA. The G5 taxi number 28, a 2018 Dodge Caravan, PA registration number TX 51833, the last 4 numbers of the vehicle identification number being 5686, driven by Anyelo J Acevedo Vega. The following violations were found:
  - a. Rear brake lamps have dark tint or screen, violating 52 Pa. Code §29.402(1) and 67 Pa. Code §175.66(g). The penalty for this violation is \$50.
  - b. Headlamps produce purplish color, color must not be contrary to Tables II-IV of Chapter 175, violating 52 Pa. Code §29.402(1) and 67 Pa. Code §175.66(g). The penalty for this violation is \$50.

**WHEREFORE**, the Bureau of Investigation and Enforcement hereby requests that the Commission fine G5 TAXI, INC, the amount of one hundred dollars (\$100) for the illegal activity described in this Complaint and order such other remedy as the Commission may deem to be appropriate.
