**FINAL ORDER**

On February 20, 2025, a Tentative Order was entered in the above captioned proceeding.

Both the Code, 66 Pa. C.S. § 2208(c)(2), and Commission regulations, 52 Pa. Code § 62.113(a)(5), state that the failure of an NGS to comply with applicable provisions of the Code or the rules, regulations, orders, or directives of the Commission shall be cause for the Commission to revoke the license of the NGS.

**Assessments and Fees**
